# **Opening**

The regular meeting of the Eyota Township Board was called to order at 7 pm on October 18, 2021, at the Eyota Ambulance Barn by D O'Neill. Pledge of Allegiance recited. Moderator was B Halvorson.

### **Approval of Minutes**

The Minutes of September 20, 2021, board meeting reviewed and unanimously approved as written.

## **Treasurer Report**

Approved and stand as read. General Fund: \$25,938.04; Road and Bridge: \$106,563.90; Fire: \$64,957.72; Fire Mutual Fund: \$19,889.88; FEMA fund: \$88,822.20.

### **Open Issues**

Fire Department update by B Halvorson. Some repairs were done on a couple of trucks. Mutual Aid is being finalized and should start at any time. D O'Neill moved to transfer \$20,000 from Fire Fund to Fire Mutual Fund. B Halvorson seconded; motion passed.

Road and Bridge update by D O'Neill. Roger Ihrke requesting a field drive on 140<sup>th</sup> Ave. He will be responsible for the costs associated with this. Berm work needs to be done on 30<sup>th</sup> St SE and 100<sup>th</sup> Ave. Will proceed with this in the spring of 2022. Road trash noted and will be picked up by township. Board reviewed letter from Teide Grabarski PPLC related to road statutes. D O'Neill will follow up with Olmsted County Public Works on better tracking of road works done by them. A couple of stop signs were stollen and township replaced them.

Utilities Installation in ROW policy titled Eyota Township Work within the ROW had final reading. B Halvorson moved to accept the policy, with D O'Neill seconding. Motion passed with accepting policy as written. Clerk to post policy on website.

J Schumann applied for Township ARPA funds. No further discussion at this time as Mr. Schumann was not present.

Minnergy is dissolving and there is discussion that the City of Eyota is interested in the Well which is in Eyota Township.

Clerk shared mailings including Olmsted County pavement repairs.
