## Treasurer Report

Stands as read. General Fund: $\$ 111,349.57$; Road and Bridge: $\$ 100,464.35$; Fire: $\$ 43,787.08$;
Fire Mutual Fund: $\$ 39,891.58$; FEMA fund: $\$ 88,822.20$; ARAP fund: $\$ 25,237.36 .2^{\text {nd }}$ Tax
Settlement from Olmsted County has been received. Plan on receiving Town Aid, Ag Credit and Fire Contract payments yet this month.

## Open Issues

Fire Department report has discussion on billing software as there are at least 4 fire calls into the township that were not reimbursed. January will see the completion of the Loan for the fire truck.

Road and Bridge Update had discussion of damage from the windstorm on December 15, 2022. There were some trees down on township roads with Olson Tree to work with D O'Neill tor removal. Discussed $30^{\text {th }}$ Street SE and the need for road maintenance in the spring. Township shared with Mr. Jones, an Olmsted County Sheriff, the concern for sign thefts in the township. Township phone numbers shared with Mr. Jones in case the sheriff department notices a missing sign. Township wanted to make the department aware of 4 wheelers potentially damaging the road and or ditches. Noted that dumping is still occurring in the ditches. Township plans to complete a Sign Reflectivity Study in the spring. The Culvert Invoice for R Irhke for $140^{\text {th }}$ Ave SE reviewed and approved to be mailed.

J Schumann to investigate using the ARPA funds. B Halvorson will follow up on setting up a Facebook page. D O'Neill has nothing to add concerning the Olmsted County Township Officer meeting held on Tuesday, Nov $23^{\text {rd }}$.

Notices to file for supervisor and clerk were placed in the Advertiser and the Dover-Eyota Eagle. Filing can occur from Dec 28, 2021, through Jan 11, 2022. Election will be on March $8^{\text {th }}$ from 5 to 8 pm .

Yearly Payroll completed and approved. Worker's compensation audit and renewal completed. Kwik Trip Federal Gas Tax exemption forms emailed. General mailings that were received, shared with the board.

Motion to pay bills totaling \$13,609.01 made by B Halvorson seconded by D O'Neill with motion passing with all in favor.
