## Opening

The regular meeting of the Eyota Township Board was called to order at 7 pm on May 17, 2021 at the Eyota Ambulance Barn by J Schumann. Pledge of Allegiance recited.

#### **Approval of Minutes**

The Minutes of April 19, 2021, board meeting were reviewed and unanimously approved as written.

#### **Treasurer Report**

Approved and stand as read. General Fund: \$12,405.92, Road and Bridge: \$135,566.57, Fire: \$30,324.57, Fire Mutual Fund: \$19,137.44, FEMA fund: \$97,562.20.

#### **Open Issues**

Fire Department reports no updates. Copy of Mutual Aid Contract with Rochester Fire is filed with clerk.

R Vehrenkamp requesting the field driveway be widened to the east on 10<sup>th</sup> street. As no culvert needed, this will be done at no additional cost to the landowner. J Lynch requesting his driveway to be widened and as this includes culvert work, this will be at the landowner's expense.

Tree removal estimates received from Olson Tree Service. After discussion by board, the tree removal to proceed on 54<sup>th</sup> street. 90<sup>th</sup> Ave SE tree removal request by snowmobile club finds trees are not in the township right of way. Township will proceed with the tree removal if the snowmobile club agrees to pay for the removal.

Spring Road Tour was completed on May 6<sup>th</sup>. Road maintenance to start this week with approximately 8 miles of road to rock. Discussion occurred on the cleaning of ditches on 10<sup>th</sup> St SE and on 140<sup>th</sup> Ave SE. The MN DNR approved the clean up on 10<sup>th</sup> Street SE, and D. O'Neill will proceed with organizing this. 140<sup>th</sup> Ave SE in a Calcareous Fen area and will require further state approval to proceed, so at this time the board has agreed to hold on any cleaning at this time.

D O'Neill has received several requests for additional Chloride. No date set for chloride application.

Clerk Report included mailings from Olmsted County Planning report, Greater Zumbro One Watershed, One Plan, and Town Web.

Motion to pay bills totaling \$903.58 made by D O'Neill, seconded by B Halvorson, motion passed with all in favor.
