Approval of Minutes

The Minutes of June 21, 2021, and July 19, 2021, board meetings reviewed and unanimously approved as written.

Treasurer Report

Approved and stand as read. General Fund: \$32,219.58; Road and Bridge: \$108,955.31; Fire: \$58,104.34; Fire Mutual Fund: \$19,888.89; FEMA fund: \$97,562.20.

Open Issues

Metes and Bounds, request from John Keefe to split off his property located in Section 30 was reviewed and approved. Letter of TownBoard Action completed, and copy sent with applicant.

Fire Department Update by B Halvorson reports that culverts were flushed. No other updates to report. Discussion for using ARPA funds to purchase a fire truck or software for billing occurred. B Halvorson will look into this further. Township is unsure how to use ARPA funds.

Road and Bridge update by D O'Neill. Roads are in good shape. Ditches on 10th street will be worked on this week. Extra fill from projects will be given to whoever request, and to be hauled at requesters expense. Trees in the ROW on 110th Ave across from Jerry Knowlton to be removed; D O'Neill will contact tree service. J Lynch self-widened his driveway with J Shea doing the work. A sign for the Randall Fork cemetery was purchased for and placed by D O'Neill. J Schumann moved to reimburse D O'Neill for this sign, B Halvorson seconded, passed with all in favor.

A new state law requires utilities to comply with township ordinances. First reading for buried broadband/utilities policy/ordinance was done.

Maintenance Agreement with Olmsted County reviewed and signed by J Schumann, Chairperson, and M Lewis, Clerk.

D O'Neill shared that Equalization Training is available on Sept 28th in Dodge County.
