Approval of Minutes

The Minutes of May 20, 2019 regular board meeting minutes were unanimously approved as distributed.

Treasurer Report

Approved as reported.

Open Issues

Public hearing on Milestone/D Kullot request for rezoning 3 acres opened at 7:07pm by J Schumann. A Peters from Milestone informed board why rezoning was requested. Board reviewed PAC recommendations and D O'Neill moved to accept PAC recommendation to rezone 3 acres from A-1 to A/RC/AER as indicated on map provided. J Schumann seconded, motion passed unanimously. Letter of Townboard action signed.

Eyota Fireman Relief Association donated \$1000 toward purchase of a future fire truck. D O'Neill moved to accept donation, J Schumann seconded, motion passed to accept donation to be placed in Fire Mutual Fund to be used for purpose of fire truck purchase.

Road work progressing with rocking of several roads. Frost Boil bill submitted to Olmsted county for state of MN/ FEMA with Olmsted County in Disaster Declaration 4442. D O'Neill will follow up with this.

Board approved for gravel be placed on current field driveway on 50th St Section 30 as requested by R Allen.

Tree Trimming decision on hold until a quote is received. Road count completed and awaiting results. Hildebrandt to start ditch mowing. D O'Neill requested chloride application rates from Filmore Co-op with plans for chloride application sometime in July.

Letter drafted to be mailed to J Johnson for unauthorized ditch work to be halted and ditches returned to previous state.

PAC meeting on July 1st for C Schroder building permit/conditional use permit. Board requesting ad to be placed for persons interested in replacement representative for outgoing PAC member.

Clerk shared following items: 2019 Survey of Olmsted County Residents results emailed to board members. Please review. FYI: June 20th Training MAT in Rochester. MAT Official Membership Cards handed out. State Demographer annual populations and household estimates reviewed by board. Milestone offering on-line invoices which were declined at this time. Viola Fire Coverage Invoice to be mailed. Haverhill has paid their annual fire coverage amount. Letter from Strobel & Hanson reviewed by board.

Motion to pay bills totaling \$3276.60 made by B Halvorson, seconded by J Schumann, motion passed with all in favor.
