**Opening**

The regular meeting of the Eyota Township Board was called to order at 7 pm on March 18, 2019 at Eyota Ambulance Barn by Maureen Lewis, Clerk. Pledge of Allegiance recited.

**Selection of Chair**

M Lewis opened the floor for nominations of chairperson. J Schumann nominated B Halvorson. B Halvorson nominated D O'Neill. Nominations closed with D O'Neill voted in as chair.

**Approval of Minutes**

The Minutes of February 19, 2019 regular board meeting were unanimously approved as distributed.

**Treasurer Report**

Approved as reported.

**Open Issues**

Metes and Bounds request by B Hammel and B Campion were approved, and letter of town board action signed for each request.

Weight Restriction request to exceed weight limit requested by Gar-lin Dairy. D Allen discussed request. D O'Neill will take photos of 125<sup>th</sup> Ave. D Allen verbally agrees to additional road repairs related to the increased weight limits if needed. B Halvorson moved to exceed the weight restriction up to 80,000 pounds for delivery of liquid feed by Westway Feed Products LLC to Gar-lin Dairy on 40th St from Hwy 42 east to 125th Ave and then north on 125th Ave to the Gar-lin Feed center until the spring road restriction are removed. J Schumann seconded; motion carried.

M & J Knowlton requesting information on how to proceed with a Metes and Bounds request. J Schumann explained the process.

C Schroeder requesting a conditional use permit for his shed for his grandparents. J Schumann explained the process. Preliminary approval given for the process to continue.

J Schoenfelder voiced his concern with the condition of 55<sup>th</sup> Street SE. Supervisors will continue to monitor the road and proceed as needed.

J Peck, Eyota Fire Department, discussed how the Fire Hall Building is nearing completion and gave a brief update on the fire department.

Road and Bridge Update with town board noting several roads and culverts issues to address. Magellan Update given.

March Election Results shared with J Schumann re-elected as town supervisor for 3 years and D Kullot re-elected as town treasurer for 2 years.

Wages set for clerk and treasurer with J Schumann motioning for \$50 per meeting with 2 additional hours at \$15/hr. Additional hours worked to be \$15/hr. Seconded by B Halvorson. Motion approved by all.

Motion to pay bills totaling at \$2,709.56 by B Halvorson, seconded by J Schumann, motion passed.

Spring Short Sessions on Monday attended by D O'Neill and J Schumann with M Lewis and D Kullot attending on Tuesday. Reminder given of OCTOA Banquet on March 23, 2019.
