**Opening**

The regular meeting of the Eyota Township Board was called to order at 7 pm on October 15, 2018 at Eyota Ambulance Barn by Jim Schumann. Pledge of Allegiance recited.

**Approval of Agenda**

The agenda was unanimously approved as distributed.

**Approval of Minutes**

**Open Issues**

M Kronenbush shared that a bigger culvert to be placed within the the next week. It is to be 15" x 32" with aprons. Discussed using Potter Construction, but B Clemens will complete this work as he is available and was originally contacted to do this work.

M Allen on 55<sup>th</sup> street reports west driveway in. The east side has lines exposed. Centrylink states will reimburse work to pothole. Email communication printed and given to clerk. Culvert removed by M Blattner on 30<sup>th</sup> street. Tree trimming in progress. Ditch Brushing to be planned for in the spring. B Hummel has a recurring hole in the ditch which D O'Neill will contact the county about.

After much discussion, the town board decided to hold on the permitting process. General consensus is that the policy in place for the Chloride application is sufficient. Fireworks to meet state and county standards. Will address any further concerns with the Winery through the PAC permitting and variance process. Citizens working in ROW need to contact township.

Resolution concerning the Road Weight Limits on Township Roads. Resolution and motion: The Township of Eyota chooses not to increase the weight limits per MN statute 169.869 Sub div8 on Eyota Township roads. Motioned by D O'Neill and seconded by B Halvorson with motion carrying by all.

No response from MNDOT related to Roundabout invoice mailed last month. D Allen-Tulley given permission to mow township cemetery.

General Election to be November 6th. Elections judges to report to Ambulance Barn at 6 am.

2018 Township Road Mileage Certification is due to county before November 7<sup>th</sup>. M Lewis will check to see if needed to be completed. Building permits in Olmsted county reviewed.

Resolution designating annual polling place for 2019, approved by board and signed by town chair.
